

## **2021 Grant Awards**

### **General Operating Grants**

#### **African Family Health Organization**

\$55,000 in support of culturally- and linguistically- sensitive health, human, and educational services to African and Caribbean immigrants and refugees.

#### **Children First** (formerly Public Citizens for Children and Youth)

\$65,000 in support of efforts to improve the lives of Philadelphia children through education and advocacy for high-quality early care and education and child health including promoting access to health insurance and health care services and reducing childhood lead poisoning.

#### **Hispanos Unidos para Niños Excepcionales**

\$30,000 in support of bilingual services for children, youth, and young adults with differentiating abilities (emotional, learning, mental, and physical) and their parents and caregivers to promote self- and family advocacy and provide academic, social, and emotional supports.

#### **Justice At Work**

\$60,000 in support of client-centered and linguistically- and culturally- competent legal services, community education, and advocacy for low-wage migrant and immigrant workers.

#### **La Puerta Abierta**

\$50,000 in support of trauma-informed mental health services to Latin(x) immigrant and refugee community members and cross-systems training of providers to promote accessible, culturally informed care.

#### **Nationalities Service Center**

\$75,000 in support of comprehensive client-centered programs and services that welcome and empower immigrants and refugees to achieve a life of safety and stability, sustainable opportunities, and meaningful community connections.

#### **Pennsylvania Health Access Network**

\$75,000 in support of efforts to expand and protect access to quality, equitable, affordable health care through coalition building, policy advocacy, and community health organizing that supports and empowers consumers to get the treatment they need and to become health equity advocates.

#### **SEAMAAC**

\$50,000 in support of linguistically- and culturally- appropriate services for immigrants, refugees, and other politically, socially, and economically marginalized community members including through integration of social services at the Hansjörg Wyss Wellness Center.

### **Capacity Building Grant**

#### **Oshun Family Center**

\$25,000 in support of racially concordant perinatal care and services for members of the Black community impacted by postpartum mood changes, birth, and racial trauma.

## **Program Grants**

### **Community Legal Services**

\$85,000 in support of the Medical-Legal Partnerships at Rising Sun Health Center and the Karabots Pediatric Care Center to address health-harming legal issues including housing, utilities, health insurance, and public benefits.

### **Education Law Center**

\$50,000 in support of legal services and advocacy to improve children's access to early intervention services and full inclusion in early childhood education.

### **Legal Clinic for the Disabled**

\$60,000 in support of the Medical-Legal Partnership at St. Christopher's Hospital for Children Newborn Clinic and Neonatology Next Steps Clinic for legal services that promote patient and family health, independence, and quality of life.

### **ParentChild+**

\$50,000 in support of home visiting services for families with children 16 months to four years old to stimulate parent-child interaction and develop language, early literacy, and social-emotional skills.

### **Philadelphia Legal Assistance**

\$60,000 in support of the Medical-Legal-Community Partnerships at the City of Philadelphia Health Centers and Federally Qualified Health Centers to address the socio-legal needs of patients and families including health access and affordability, public benefits and income supports, and housing.

### **The Village of Arts and Humanities**

\$45,000 in support of Creative Youth Development programs which build the skills and networks of children, teens, and young adults to make successful transitions to adulthood, marked by health and well-being, economic stability, and civic engagement.

## **Collaborative Funding**

### **Black Community Leaders Fund of the Philadelphia Foundation**

\$50,000 in support of building the capacity and resilience of black-led, black-serving nonprofit organizations in Greater Philadelphia.

### **Health and Human Services Fellowship Program**

\$72,628 to SEAMAAC in support of a new Health and Human Services Fellow. This is a joint program with the Independence Foundation to promote a diverse, equitable, and inclusive leadership pipeline in the nonprofit and health and human service sectors.

### **University of Delaware Attachment Biobehavioral Catch-Up Lab**

\$230,150 in year two support for 2020 - 2023 grant (\$660,300) to expand delivery of the evidence-based Attachment Biobehavioral Catch-Up Program in the Philadelphia Infant Toddler Early Intervention system with a focus on promoting early childhood social-emotional development. The three-year program is co-funded by the William Penn Foundation.

### **Family Recovery Fund Matching Grants**

We extend our gratitude to the William Penn Foundation Family Recovery Fund for generously matching seven of our 2021 grants leveraging a total of \$360,000 for the following grantees: African Family Health Organization, Hispanos Unidos para Niños Excepcionales, Justice at Work, La Puerta Abierta, Legal Clinic for the Disabled, Philadelphia Legal Assistance, and The Village of Arts and Humanities.
